
## WELCOME TO THE THIRD HISPANIC FARMERS AND AGRICULTURAL PROFESSIONALS SYMPOSIUM!

# SPEAKERS BIOGRAPHIES



### **Terry Cosby**

Chief, Natural Resources Conservation Services USDA-NRCS

NRCS Chief Terry Cosby began his career with the agency in 1979 as a student trainee in Iowa. Over Terry's 42 years with the agency, he has served in numerous capacities. He had been the NRCS State Conservationist for Ohio since 2005. Mr. Cosby grew up in a cotton farm with his eight siblings in Tallahatchie County, Mississippi. The farm was purchased by his great-grandfather in the late 1800s.



#### Gloria Montaño Greene

Deputy Under Secretary for Farm Production and Conservation, USDA-NRCS

Montaño Greene is a former State Executive Director for the Farm Service Agency in Arizona from 2014-2017. Montaño Greene served as Deputy Chief of Staff and Chief of Staff to Congressman Raúl M. Grijalva of Arizona. Montaño Greene also served as Deputy Director for Chispa Arizona, a program of the League of Conservation Voters focused on the empowerment of Latino voices in Arizona on issues including energy, public lands, and democracy access.



#### **Robert Satterfield**

Acting Executive Director, North Carolina Farm Services Agency (FSA)

Satterfield is FSA Acting State Executive Director for North Carolina and also handles the CFAP program. He started working with Farm Services Agency for 36 years and previously worked in Caswell, Person, Orange, Durham, Granville, and Warren Counties before moving to the State Office in 2012.

Hernández has a bachelor's degree in Business Administration with a concentration in Accounting from the Pontificia Universidad Católica in Ponce, Puerto Rico. ## PROGRAMA DE ASISTENCIA ALIMENTARIA CORONAVIRUS 2



El Departamento de Agricultura de los Estados Unidos (USDA) está brindando un apoyo fundamental a los productores agricolas y ganaderos de nuestro país a través del Programa de Asistencia Alimentaria Coronavirus 2 (CFAP 2). El CFAP 2 brinda asistencia financiera esencial a los productores que continúan enfrentando la desorganización del mercado y los costos asociados debido al COVID-19.

#### Resumen

El USDA comenzará a brindar asistencia financiera extra a los productores, entre ellos los productores agrícolas y ganaderos, que se han visto afectados por la desorganización del mercado debido al COVID-19, a través de la iniciativa Asistencia a Productores durante la Pandemia.

El período original de postulación al CFAP 2 finalizó el 11 de diciembre de 2020. El USDA reabrió la inscripción al CFAP 2 a partir del **5 de abril de 2021**, por **al menos 60 días**. Más adelante se anunciará la fecha de cierre de estas inscripciones.

#### ¿Quién es elegible?

Los productores (personas o entidades jurídicas) de determinados productos agrícolas que enfrentan la continua desorganización del mercado y los elevados costos de comercialización son elegibles para recibir pagos en virtud del CFAP 2.

#### Para ser elegible para recibir pagos, una persona o entidad jurídica debe:

- tener un ingreso bruto ajustado promedio de menos de \$900,000 para los años fiscales 2016, 2017 y 2018; u
- obtener al menos el 75% de su ingreso bruto ajustado de actividades relacionadas con la agricultura, la ganadería o la silvicultura.

## Las personas y entidades jurídicas también deben:

- producir comercialmente los productos elegibles;
- participar del negocio de la agricultura al momento de presentar la solicitud;
- cumplir con las disposiciones de las regulaciones de "Conservación de tierras altamente erosionables y humedales", a menudo denominadas "disposiciones de cumplimiento con la conservación";
- si es una persona extranjera, proporcionar tierra, capital y una importante cantidad de trabajo personal activo a la operación agrícola, y
- no haber cometido una violación en relación con el uso de sustancias de uso controlado.


Los productos cultivados en virtud de un contrato en el cual el productor tiene riesgo respecto de la producción y la propiedad son elegibles para el CFAP 2.

#### Productos elegibles

Los pagos del CFAP 2 se dividirán en tres categorías de productos:

- Productos de activación del precio
- Cultivos de tasa uniforme
- 3. Productos de venta

# **Checklist for New Farmers**

This brief summary is intended to acquaint you with some of the common first considerations. You should research your local, State, and Federal requirements fully and make the best decisions for your farm or ranch business in accordance with your priorities.

## Planning

- Secure farm business location(s) (purchase, rent, or lease).
- Complete farm planning process (production, marketing, and financial plans).
- Select and develop farm products and/or services.

## **Advice**

- Review your farm business plans with an advisor.
- Research what resources might be available to support your business and vision.

## Education

 Attend field days, workshops, courses, or formal education programs to build necessary skills to ensure you can successfully produce your selected farm products and/or services.

## Funding

• Secure necessary financing (farm capitalization and operating); establish credit with key suppliers.



## Set Up Your Business

- Establish farm legal structure (e.g., sole proprietorship, partnership, corporation, cooperative).
- Register your farm business and get a farm number; obtain business certificate.
- Obtain tax identification numbers for the farm business:
- Sales Tax
- Employer's Tax
- Acquire necessary permits, licenses, and certifications; prepare to comply with all relevant regulations:
- Local
- State
- Federal
- Purchase necessary insurance (e.g., liability, health, life, crop, property, workers' compensation).
- Establish farm work plan; hire and schedule farm labor.

## **Other Key Considerations**

- Establish farm management team and job descriptions (e.g., family members and partners, employees, lawyer, accountant, other consultant services).
- Open farm business bank account(s).
- Set up farm business office; obtain necessary supplies and equipment.
- Set up farm bookkeeping and recordkeeping systems.
- Establish farm policies (personnel, safety, visitor).
- Establish distribution channels/markets for farm products.
- Produce promotional and advertising material.

# Lista para nuevos agricultores

Este breve resumen tiene la intención de familiarizarlo con algunas de las primeras consideraciones básicas. Debe investigar los requisitos locales, estatales y federales a cuidadosamente y tomar las mejores decisiones para su negocio de finca o rancho, de acuerdo con sus prioridades.

## Planificación

- Asegure la localización(es) y dirección(es) de los negocios agrícolas (compra, alquiler o arrendamiento).
- Complete el plan y el proceso de su negocio agrícola (producción, comercialización y planes financieros).
- Seleccione y desarrolle productos y / o servicios agrícolas.

## Consejo

- Revise sus planes de negocios agrícolas con un asesor.
- Investigue qué recursos podrían estar disponibles para ayudar su negocio y visión.

## Educación

 Asista a los días de campo, talleres, cursos o programas de educación formal para desarrollar las habilidades necesarias para garantizar que pueda producir con éxito los productos y / o servicios agrícolas seleccionados.

## Fondos

 Asegure el financiamiento necesario (capitalización y operación de la granja); establecer crédito con proveedores o suplidores que sean claves a su empresa agrícola.



## Configure/constituya su negocio

- Establecer la estructura legal de la granja o finca (por ejemplo, propiedad única, sociedad, corporación, cooperativa).
- Registre su negocio agrícola y obtenga un número de granja o finca; obtener certificado comercial
- Obtenga números de identificación fiscal para el negocio agrícola:
  - Impuesto de venta
  - Impuesto del empleador
- Adquirir los permisos, licencias y certificaciones necesarios; Prepárese para cumplir con todas las regulaciones relevantes:
  - Local
  - Estado
  - Federal
- Compre el seguro necesario (por ejemplo, responsabilidad civil, salud, vida, cultivo, propiedad, compensación de trabajadores).
- Establecer un plan de trabajo agrícola; contratar y programar mano de obra agrícola.

## Otras consideraciones claves

- Establecer el equipo de administración de la granja y las descripciones de trabajo para cada uno (por ejemplo, miembros de la familia y socios, empleados, abogado, contador, otros servicios de consultoría).
- Abrir cuentas bancarias de negocios agrícolas.
- Establecer una oficina de negocios agrícolas; obtener los suministros y equipos necesarios.
- Establecer sistemas de contabilidad y mantenimiento de registros agrícolas.
- Establecer políticas agrícolas (personal, seguridad, visitante).
- Establecer canales de distribución / mercados para productos agrícolas.
- Producir material promocional y publicitario.
